**Vendor Fee Information:** Vendors will be given an outdoor space; all vendors are responsible for their own tent coverage, tables and chairs. (Tents / Tables / Chairs will be available for rent)

Tables(s) \$10.00 each    Chair(s) \$5.00 each    10 x 10 tent \$150.00 each

**Non-Food Vendor Fee:** \$95.00; Fee includes a 10 x 10 space.

**Wine and/or Cider Vendor Fee:** \$175.00; Fee includes a 10 x 10 space.

**Distillery Vendor Fee:** \$475.00; Fee includes a 10 x 10 space. (Vendor fee will be used to purchase your product for sampling. You may increase the vendor fee if you would like us to purchase more of your product.)

**Food Vendor Fee:** \$175.00; Fee includes 20 x 20 space, access to water and electricity.

- 1. Vendor gates will open 3 hours prior to the event. Vendors must be in place and ready for service 30 minutes prior to gate opening. If you arrive late you may not be allowed to set-up and may not be given a refund.**
2. All vendors will be located outdoors for 2019. We reserve the right to alter this in case of weather. Events will be held rain or shine.
3. Vendors will not be accepted without full payment being made prior to the event.
4. No pets allowed, and no outside food or drink shall be permitted.
5. Security and local Law Enforcement will be on-site.
6. Vendor employees will be admitted free.
7. Event parking is FREE. Please understand that during show hours all vendor vehicles must remain in the designated parking areas due to high volume of foot traffic, and road closures within the festival area.
8. Booths must be staffed at-all-times.
9. Displays must stay assembled and product must be available until the end of the show. NO PACKING UP EARLY! *Vendors who pack up early MAY be ineligible for all future events.*
10. ALL vendors that wish to sample alcohol MUST purchase a vendor admission ticket. (Each vendor may purchase up to 2 discounted tickets.)
- 11. All Vendors MUST have all permits and/or licenses for operating business in the City of Fredericksburg.**
12. A \$150.00 returned check service charge will be assessed for each dishonored check the bank returns.
13. We reserve the right to remove/expel any applicant without refund.
- 14. NO REFUNDS will be given 60 calendar days prior to each event.**
